NOW, THEREFORE, in consideration of the manual promises contained herein, the partied agree as follows:

1.Definitions

As used herein, the following terms shall have the meanings set forth below:

- A. Direct Seller will have the title of "Distributor"
- B. "Direct Selling" means marketing, distribution and sale of goods or providing of services as port of network of Direct Selling other than under a pyramid scheme.

 Provided that such sale of goods or services occurs Otherwise than through a "permanent retail location" to the consumers, generally in their houses or at their workplace or through explanation and demonstration of such goods and services at a particular place`
- C. "Direct Selling Entity" means an entity i.e. [Miraculous Wellness Pvt. Ltd.], not being engaged in a pyramid scheme, Which sells or offer to sell goods or service through a direct seller? Provided that "Direct Selling Entity" does not include any entity or business notified otherwise by the Government for the said purpose from time to time

2. Indemnification by Distributor

Distributor shall indemnify and hold Company free and harmless from any and all claims, damages or lawsuits (including reasonable attorneys'fees) arising out of negligence or malfeasant acts of Distributor or misrepresentation or breach of any obligations under this agreement.

3. Conduct for the Protection of Consumer

- 1.1 The relationship between Miraculous Wellness Privet Limited and Distributor shall be determined as per the written agreement between the parties which shall contain the rights and obligations that are expressly provided as conditions for the conduct of Direct Selling businesses well as provide for the obligation of the Miraculous Wellness Privet Limited and the Distributor in terms of these guidelines:
- 1.2 All other rights and obligations shall be determined as per the express
 - Terms of written agreement between a Miraculous Wellness Privet Limited and
- 1. Miraculous Wellness Privet Limited will be liable for grievances arising out of sale of products, services or business opportunity by its Distributor
- 2. It will be the responsibility of the Miraculous Wellness Privet Limited to monitor and control the practices/methods adopted by the Distributor
- 3. Distributor and Miraculous Wellness Privet Limited shall take appropriate steps to ensure the Protection of all private information provided by a consumer,
- Direct Sellers and Miraculous Wellness Privet Limited be guided by the provision of the Consumer Protection Act 1986.
- 5. All complaints received over phone, email website, post and walk-in should have a complaint number for tracing and tracking the complaint and 15 days taken for redressal.
- redressal.
 6. Miraculous Wellness Privet Limited constitute a Grievance Redressal Committee Whose composition, nature of Responsibilities shall include but not limited to:
 - a. The Grievance Redressal Committee shall consist of at least three officers the Miraculous Wellness Privet Limited b) The Grievance Redressal Committee shall address complaints and inform complaints of any action taken
 - b. Complaints maybe made by any member of general public against a Distributor of the Company, an employee or any other officer of the entity c. All such grievances will be resolved directly by the Miraculous Wellness Privet Limited.
- 7. Distributor who sells or offer the sale, including one an e-commerce platform/marketplace, any productor service of a Miraculous Wellness Privet Limited must have Prior written consent form the respective Miraculous Wellness Privet Limited in order to undertake or Solicit such sale or offer.

4. Refund Policies

Notify and provide a full refund or buy back guarantee to every Distributor on Reasonable commercial terms which can be exercised within a period of 180 days, From the date of the distribution of the goods or services to the Distributors. From the consumer refund of product in 30 days.

5 Term and Termination

- A. Term. This Agreement shall commence on the date first written above for a period of [1 year] unless terminated earlier as provided herein below.
- B. Termination. Either party to this agreement shall have the right to terminate this agreement with a prior written notice of thirty (30) days to the other party.
- C. Return of Materials. All of Company's trademarks, trade names, data, photographs, literature, and sales aids, customer related database of every kind shall remain the property of Company. Within five (5) days after the termination of this Agreement, Direct seller shall return all such items to company. Distributor shall not make or retain any trademarks, marks and trade name of Company.
- D. This agreement will be reviewed by the company after a period of [12 months]. Any Direct seller not performing to the full satisfaction of the company in terms of securing new orders and company's policies is liable to be terminated.

6. Limitation of Liability

In the event of termination by either party in accordance with any of the provisions of this Agreement, neither party shall be liable to the other, because of the termination for compensation, reimbursement or damages on account of the loss of prospective profits or anticipated sales or on account of expenditures or commitments in connection with the business or goodwill of Company or Direct seller.

7. Governing Law and Jurisdiction

This Agreement will be governed by and construed in accordance with the laws of Republic of India. Each party irrevocably and unconditionally submits to the exclusive jurisdiction of the Jodhpur (Rajasthan).

8. Entire Agreement

This Agreement sets forth the entire agreement and understanding of the parties relating to the subject matter herein and supersedes any prior discussion or agreements between them. No modification of or amendment to neither this Agreement, not any waiver of any rights under this Agreement to be done unilaterally and it shall be effective unless in writing signed by the party to be changed.

9. Notices

Any notices required or permitted by this Agreement shall be deemed given to registered Address of both parties.

10. Arbitration

In case of any dispute the matter first should be solved through arbitration.
